# **Our Services**



## **Work Permit**

Work permit allows a Foreign National to come work in Canada. It is categorized into **Open Work Permit and Employer-Specific.** 



## **Study Permit**

This is a temporary resident permit. A foreign national can come to Canada to Study by applying for a study permit.



## **Visitor's Visa**

A foreign national can come visit Canada on family, Business, or tourist basis. A tourist visa allows a foreign national up to 6 months temporarily in Canada. Another Category is the Parent/GrandParent Visa (Super Visa). This type of visa allows a parent/grandparent who has a child/grandchild in Canada to visit Canada. The grand child/ child must be a permanent resident or Citizen to be eligible to invite the Foreign national. Visa is usually valid for up to 5 years.



### **Sponsorship Application**

The spouse of a Foreign National who is a worker, Permanent resident or Citizen could be sponsored under the spousal sponsorship program. The spouse and other dependents can come to Canada through this immigration pathway.



### **Permanent resident application**

Although there are several pathways to become a permanent resident in Canada, part of which is the common Express Entry pathway. This is open to Foreign Nationals who have interest to settle in Canada permanently and meet the eligibility requirements. General requirements are proof of education that meets Canadian standards, proof of English Language proficiency and proof of funds to settle in Canada.

# Provincial Nominee Programs

The Express Entry program governed by the federal government, nonetheless, provinces and territories also provide immigration pathways for permanent economic settlements for foreign nationals also called Provincial Nominee Programs. Each province and territory have their own requirements to meet their social and economic needs.

# Provincial Nominee Programs

This class is included as a Visit Visa. Foreign nationals can come visit Canada on the subject of business fostering. This could be in the form of business partnership opportunities, seminars, business invitations and all.



## 🖗 Francophone Mobility

The Government of Canada launched this program in 2016. This is under the work permit category. Foreign nationals who can show evidence that they can communicate effectively in French language and intend to reside outside of Quebec may be eligible to apply.
